Deliveries to consumer residences are excluded. Effective February 29, 2016, processors of certified "organic" and "100 percent organic" fluid milk products may apply for an organic assessment exemption for those products.

The Class I skim price for the Southwest Marketing Area is the average of the monthly Class III skim and Class IV skim advanced pricing factors plus \$0.74 per hundredweight plus \$3.00, subject to the adjustment for that location.

The Class I butterfat price for the Southwest Marketing Area is the advanced butterfat pricing factor plus \$0.030 (\$3.00 divided by 100), subject to the adjustment for that location.
