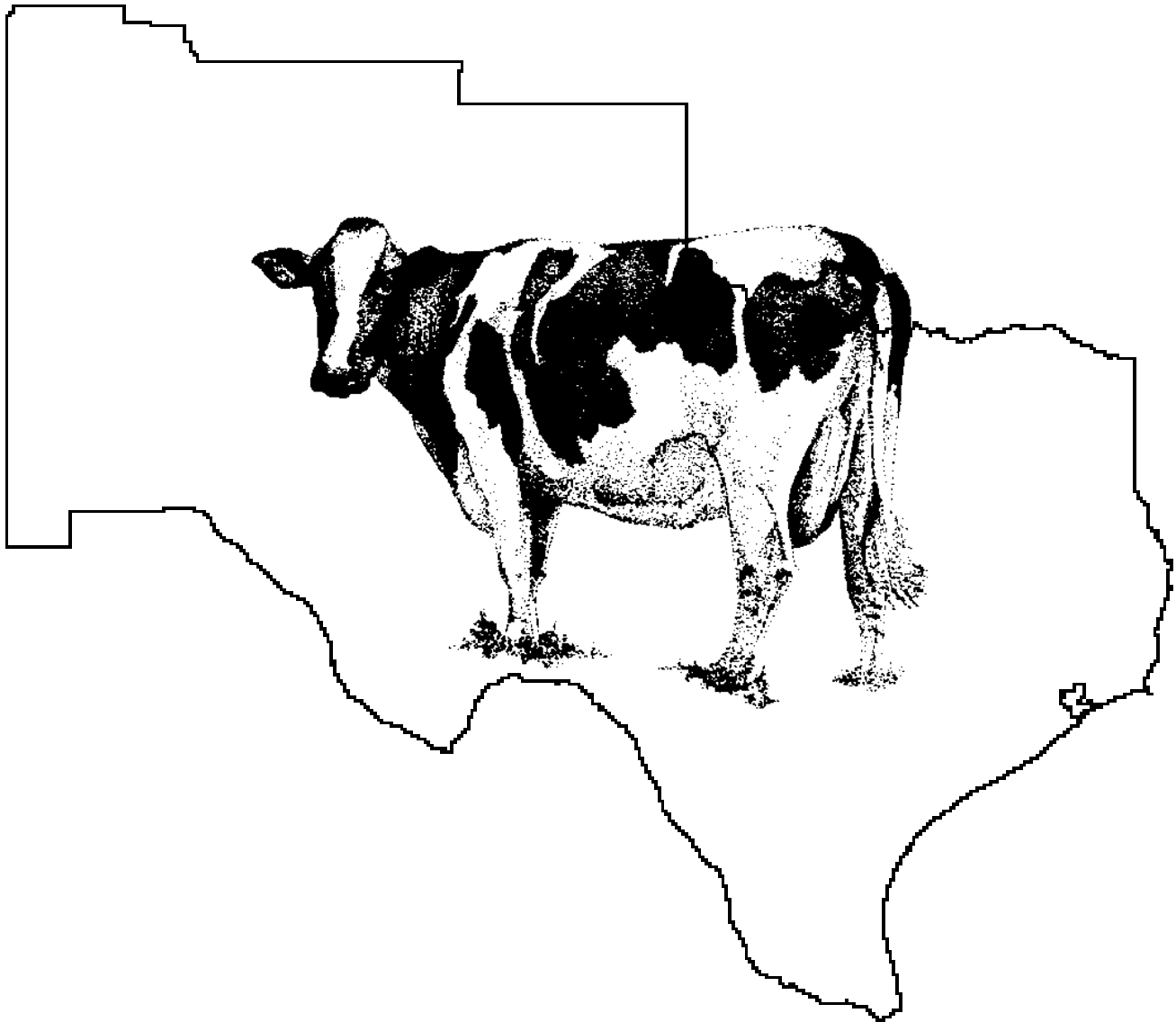

Map - Southwest Federal Order No. 126

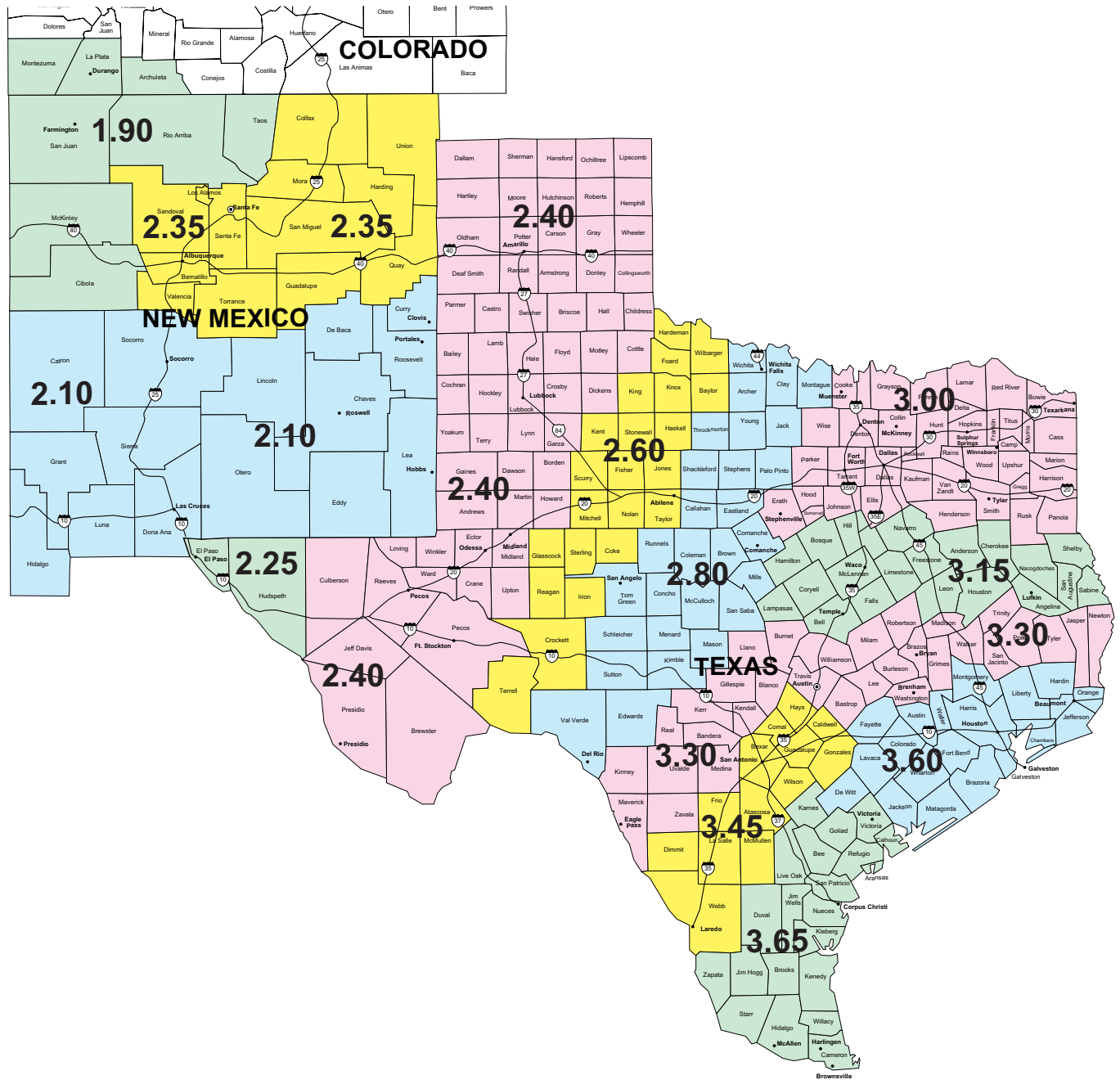
