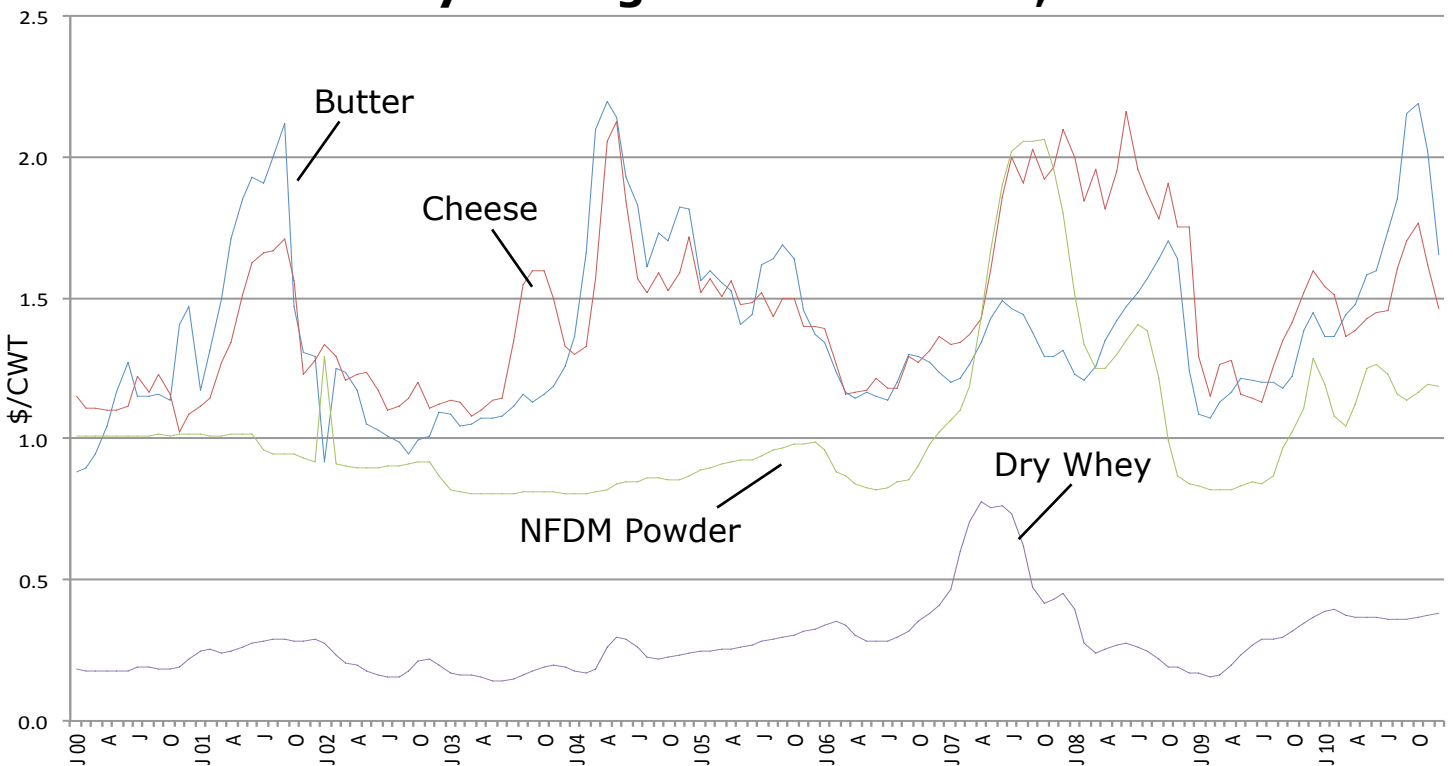

Component Prices Used to Compute Class and Producer Milk Value, 2000-2010

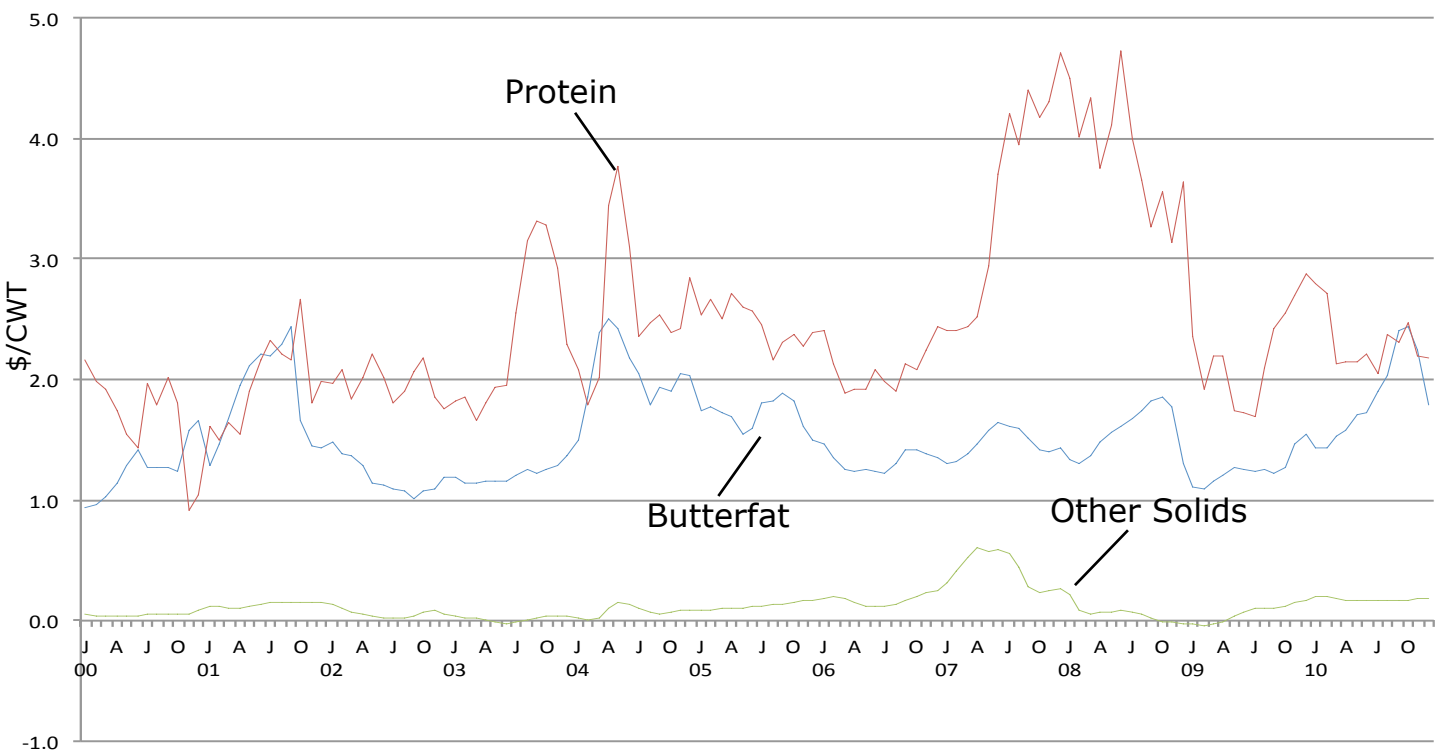

Class I and Statistical Uniform Prices, 2000-2010

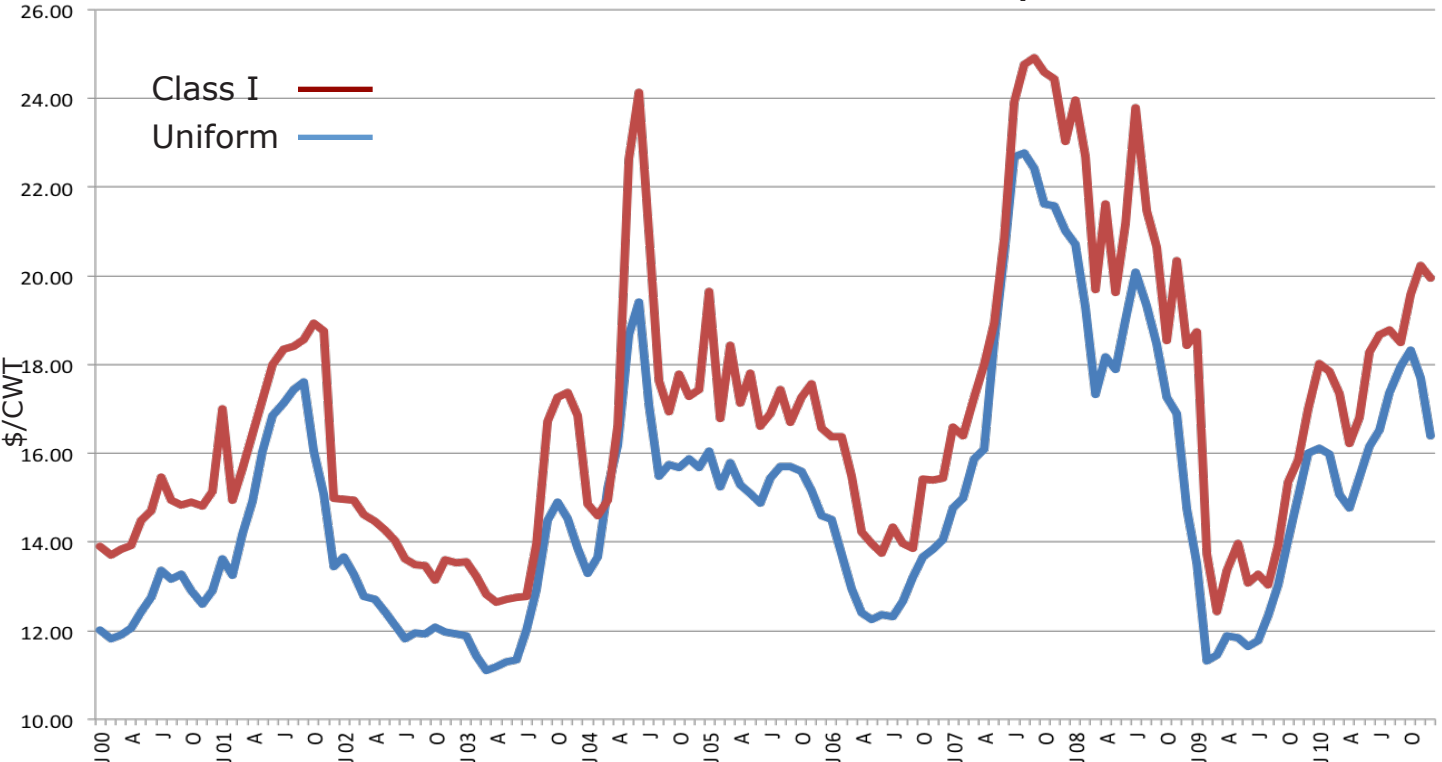
